<b>Am I required to provide the Company with my personal data</b>	You are required to provide the minimum personal data necessary for us to manage your contract and our contractual agreement. Failure to provide the minimum necessary personal data we require could prevent us being unable to fulfil our contractual agreements/service agreements with yourselves.
<b>Does the Company's processing of my personal data involve automated decision making, including profiling?</b>	Yes. Automatic decision making would take place if this was in the public interest: i.e. major gas leak and we were unable to get in contract with our client, we would make the decision to turn this off.
<b>Can I withdraw my consent for processing</b>	<p>You can withdraw your consent for the processing of your personal data at any time if that processing is on the sole basis of your consent (Processing basis 6).</p> <p>Please be aware: Selmec do not hold any personally identifiable details for companies, only company information.</p>
